### Notice of Business Alliance that Includes Establishment of Joint Venture

The Board of Directors of EBARA-UDYLITE CO., LTD. (the “Company”) approved a resolution on June 22, 2009 to establish a business alliance with a company in China. As part of the alliance, EBARA-UDYLITE will establish a joint venture with this company. Details are as follows.
